One to be elected by the Full Members of the ACA from among their representatives (Rule 14 (2) (a) of By-laws of ACA)



If there is any objection regarding the eligibility of the authorized representative, the full members are requested to send two passport size photographs attested by the President/Secretary of District Association/Club of the newly authorized representative mentioning the name of the person on their letter head duly signed by President/Secretary of District Association/Club on or before 5.00 PM on 14th August, 2024.

Election process shall form a part of the Special General Body Meeting of the Andhra Cricket Association to be held on 08<sup>th</sup> September 2024 in Guntur, Andhra Pradesh.

**GUIDELINES TO THE FULL MEMBERS OF ACA TO SEND THEIR AUTHORIZED REPRESENTATIVE AS PER THE MOA AND RULES AND REGULATIONS OF ACA**


1. Person/Representative shall be a member of your Association/Club
2. The authorized representative who has Right To Vote and Right to Contest in ACA office bearers and councillor elections are eligible to attend SGM of ACA to be held on 08<sup>th</sup> September, 2024 at Guntur
3. The authorized representative shall be disqualified if he/she :

a) Is not a citizen of India

- Has attained the age of 70 years.
- Is declared to be insolvent or of unsound mind
- Is a Minister or Government servant
- Has been an Office Bearer of ACA for a cumulative period of 9 years
- Has been convicted by court of law for commission of criminal affairs and sentenced to imprisonment.
- Has not completed a cooling period of 3 years after holding the post of an Office Bearer for two consecutive terms (6 years) in ACA.
