The full members of ACA have to submit the names of their authorized representatives along with two photographs on or before **11th March 2026**.

If there is any objection regarding the eligibility of the authorized representative, the full members are requested to send two passport-size photographs attested by the President/Secretary of the District Association/Club of the newly authorized representative mentioning the name of the person on their letterhead, duly signed by the President/Secretary of the District Association/Club, **On or before 05:00 PM on 15th March 2026**.

The election process shall form a part of the Special General Body Meeting of the Andhra Cricket Association to be held on **05th April 2026**.

GUIDELINES TO THE FULL MEMBERS OF ACA TO SEND THEIR AUTHORIZED REPRESENTATIVE AS PER THE MOA AND RULES AND REGULATIONS OF ACA

1. The Person/Representative shall be a member of your Association/Club.
2. The authorized representative who has the Right to Vote and the Right to Contest in Andhra Premier League (APL) Governing Council Elections (for the term of 2026-27) elections is eligible to attend the **Special General Meeting (SGM)** of ACA to be held on **05th April 2026** at Vijayawada.
3. The authorized representative shall be disqualified if he/she:
 - a) **Is not a citizen of India**
 - b) **Has attained the age of 70 years**
 - c) **Is declared to be insolvent or of unsound mind**
 - d) **Is a Minister or Government servant**
 - e) **Has been an Office Bearer of ACA for a cumulative period of 9 years**
 - f) **Has been convicted by a court of law for the commission of criminal affairs and sentenced to imprisonment**
 - g) **Has not completed a cooling period of 3 years after holding the post of an Office Bearer for two consecutive terms (6 years) in ACA**
