Please duly take note of the following important instructions forthwith .

It has been represented by members individually , in view of a flood like situation prevailing in Vijayawada and its neighbourhood ; there could be hardship for personal attendance for members .

While the worst of the above episode is seemingly over , the weather forecast has to be taken heed in the prevailing circumstances to mitigate possible hardship arising to members to undertake travel .

In the light of the present not so ordinary circumstances and uncertainties of weather as well as the contingencies to undertake safe travel , I have given due and reasoned consideration to the representations received as to the modalities of conducting elections duly keeping in view the convenience and the genuine apprehensions to undertake travel expressed by members .

I have therefore come to the reasoned conclusion to hold the scheduled elections without postponement through a hybrid mode . This is a legitimate , legal and valid process .

Hence please communicate the decision of the Election Authority to hold a virtual meeting through Zoom as a valid option in addition to physically attending the meeting which is scheduled for 08-09-2024 at 11-30 am at the Vijayawada club situated in Guntur District as already notified and communicated .

It should be mandatory to authenticate the members who have given valid option to participate by Zoom and establish their identities as well as maintaining foolproof record . Their options in writing shall be first obtained , authenticated and produced before the election authority well in advance to complete satisfaction .

Other than the recognised member , no others shall participate in the Zoom conference and a member participating shall be uninfluenced by any external circumstances and their privacy protected . A member's privacy of participation is an essential condition other than the presence of a technician assisting him in the Zoom meeting so needed .

A roll call will be first taken by 11 am on 08-09-2024 and a report of members opting to participate through Hybrid / Zoom mode shall be recorded and authenticated to the satisfaction of election authority . After this , the physical presence of members present will be verified .

In view of the reasonable , adequate and advance notice of hybrid meeting now communicated in advance , any abstention of members shall be deemed as wilful and will be so recorded by the Election Authority duly . This too shall be explicitly communicated to the members forthwith and the record of having so communicated is to be produced well before Election Authority before commencement of election process .

However the Election Authority reserves the right to revise his decision in light of unforeseen circumstances that may arise due to the weather conditions and circumstances that can't be predicted or anticipated with due consideration to safety first .
